DEAR MEMBERS,



I now start the second half of my term as your President. It is a fortuitous time as we recently enjoyed the Christmas festive season, rejoiced the advent of 2017, celebrated Pongal and welcomed the Year of the Rooster. It is therefore a good time to reflect and realistically take stock of achievements to date as well as to identify the tasks ahead.

Your General Committee had two immediate priorities when we took office. Foremost, was to secure an extension of our lease for Dataran. This was an imperative as the lease was slated to expire on 30th November 2027 – only 10 years from today. Your GC worked tirelessly to expedite the process and the outcome exceeded expectations as our Government has graciously granted a lease extension of a further 60 years. Simply put, the RSC will remain as an icon of our nation at least until 2077.

We are now negotiating with the Government for the payment of a nominal premium and we are optimistic in obtaining this given our multi-faceted roles in sports development, tourism and service to the community. I am also happy to report that we have made much progress on the transfer of our title for the Kiara Sports and we anticipate the conversion in the next few months.

Our second priority, was to place our Club on a firm financial footing. It was critical for your GC to address of the deficit RM1.4 million forecasted by the earlier GC since a failure to do so would have resulted in the Club being bankrupt within five years. Although it was a daunting challenge, we have, as stated in the Budget EGM held in December 2016, succeeded in reversing the earlier accumulated losses and as for 2017 we have actually budgeted a profit. This is manifested by the Club placing RM500,000.00 into a fixed deposit account for 2017. By doing so, we have terminated the financially unhealthy past practices of drawing down and depleting our Club's verv limited financial reserves

Yes, we are finally back in "the black" but we did not approach the issue by raising prices: We did the converse by reducing prices. Indeed, our beer prices are among cheapest in town. This the combined with new affordable dishes in our menus increased patronage and revenues. The Chinese Restaurant, benefiting from a new caterer, is now another a major revenue source for the Club.

Concurrently your Finance Sub-Committee introduced stringent financial and procurement procedures. Consequently, our bills for the purchase of our groceries have been reduced. Our liqueur stocks have also been reduced thus freeing up funds for working capital and improving our bottom line.

I thank members for their positive feedback. This indicates that we are well on track to achieving the twin goals of long term sustainability and meeting the expectation of all our members. While we are reassured by this, we remain mindful of the importance on building on the momentum gained and to address the challenges that remain. Among them, is to shore up our reserves to meet the costs of undertaking urgent capital works such as fixing our age old plumbing and electrical wiring. These, together with refurbishment works and enhancements, were kept on hold due to the uncertainty of the lease extension.

The Club is now organising some fantastic events like the Chinese New Year ball on 11th February and the Pongal Night on 26th February. I urge you all to make an effort to attend these events and maximize the use of our Bars and Restaurant facilities. After all the RSC is your Club and its continuing success also hinges on your greater patronage.

Happy Chinese New Year and best wishes for a prosperous 2017!

I would like to thank the President and the General Committee for asking me to take the role of the Vice President and hope that I can justify their confidence in me. I could not be more pleased to be serving the Royal Selangor Club (RSC).

Now that the General Committee is back in full swing and noting that the Club has managed to obtain another 60 years for our lease, a number of renovations and repairs that had for long been held at bay due to the lease extension issue, will now have to be looked into.

The Dataran building requires some major renovation work and as a start the Capex items for 2017 are currently being worked on. Repairs to the Gents toilet located at the Lobby entrance of Dataran, a lift form the car park to the Ballroom, the floor at the Verandah Restaurant, repairs to the squash court flooring and a new walkway form the Chinese Restaurant to the Ballroom have been approved for our Dataran Complex. At Kiara we have repairs to be done for the perimeter drains located at the Car park area and a much needed facelift to the entrance steps to the Lobby. All of these works along with upkeep and maintenance of facility the entire including upgrading of our electrical systems, water system and the like will keep us busy for quite some time.

On the social front a number of social events are being organised and we hope to see more patronage

from our members for these functions, especially in terms of bringing along family and friends to attend these events.

We have about 40 new members who will be joining the Club February this year. Welcome to all our new members and we hope that you enjoy the friendly culture, the camaraderie and fellowship that are the mainstay of the RSC. You have over nineteen Sports Sections to choose from and numerous activities that you and your family can participate in. It is my fervent hope that you will immerse yourselves in the activities of the Club.

On the F&B front a number of promotions are ongoing and there are numerous options available for members. Specific mention is to be made on our price for Carlsberg draught, which at RM6.80 per pint is, I believe, the least expensive in Malaysia! The Whisky of the Month Promotion will be ongoing for 2017 and our 10% off on pouring brands will continue till end February 2017. Our Chinese Restaurant will have their weekly and monthly promotions as well. At the time of writing the commencement of the Indian Stall at Kiara is almost complete and will kick off by mid February 2017. We are still going through the tender process for the Japanese Stall that is currently vacant at the Verandah Restaurant in our Dataran complex.

May I take this opportunity to wish one and all a very Happy and Prosperous 2017

EDITORIAL



Our Club starts 2017 and welcomes the Year of the Rooster with much rejoicing and celebration as we have overcome the two fundamental issues that threatened its survival.

The first was the unpalatable reality of vacating Dataran by 2026 – only 9 years away. Thanks to the tenacious and catalytic efforts of our President and his General Committee the Government has granted a 60 year lease until 2016. This welcome announcement enables the Club to implement a number of wide ranging initiatives for its long term betterment. Equally important, it provides the opportunity for members' children and grandchildren to maintain the Club's importance as a national symbol and institution.

The second - is the long awaited financial stability of the Club. As announced by the President at the Budget EGM held on 18th December 2016, the current Committee inherited the deficit of RM1.4 million. Undoubtedly if left unchecked, the trend would have resulted in the Club becoming insolvent within 5 years.

We are informed the Finance Com-

conducting mittee after an independent audit to determine actual financial status, took measures necessary to reduce costs, stop leakages, renegotiate suppliers' contracts and generate new revenue streams. They have succeeded admirably in reversing the earlier accumulated losses and contrary to earlier practises, have shored the Club's reserves by setting aside RM500,000 into a fixed deposit account!

Members who attended the last EGM will recall that the Budget for 2017 received the unanimous support of the House. Since the four tabled Resolutions received similar support, this clearly indicates that the President and the General Committee are back on track for ensuring the sustainability of the Club.

This edition of the Berita highlights the President's message where he modestly reports on the achievements to date on several fronts. Another interesting read is Professor Dr A. Selvanathan's second article on the history of the Club which focuses on the post-independence era.

In keeping with its sporting traditions the Club organized, in recent months, several tournaments in Rugby, Billiards, tennis, Darts and Football among others. The Dato' Chu Ah Ngee Soccer Tournament held on 3rd December 2016 attracted a record number of participants.

Throughout its long history, our Club has always been known for its good entertainment, food and fine wine. The traditional New Year's Eve Ball was held at Dataran and, as reported in page 31, more than 300 formally attired members and their spouses ushered in the New Year with much cheer and merriment.

In response to members' demands, The Club again played host to Kabali. Featuring the superstar Rajinikanth, many of scenes for this most watched Indian movie globally, were shot in the Club in March 2016. A Kabali evening featuring Malaysia's own Rajinikanth was held with the packed crowd on30th November 2016.

On the food front, members would have noticed that our beer prices are now the lowest in town. Our food prices have also been reduced resulting in the full patronage of the various outlets. Our reopened Chinese Restaurant, with a new caterer, has received accolades from members for its exquisite Chinese cuisine.

Readers would note that this edition of the Berita has some changes. The genesis of this is the constructive comments from all readers and I thank all of them for this. I also thank the Sports Sections for their contributions as well as the General Manager and his team of dedicated staff for meeting publication timelines.

And now that the 'holiday season ' is past, it is time to look forward to the Chinese New Year ("CNY") celebrations, which will be early this year at the end of January.

2017 will be another busy year for the Club. The General Committee has been working closely with Management to evaluate and identify key components for both the Club's Strategic Plan and the coming year's operations. Two major renovation works, the flooring at the Verandah Restaurant and part of the Food Court area and the renovation to the Gents toilet at the Dataran Lobby entrance will be undertaken in February. A number of Capex works which were approved at the EGM in December 2016 will commence and be completed as scheduled. In the case of the Verandah Flooring renovations, the restaurant will be temporarily moved up to the Cocktail Lounge for an estimated period of 5 weeks while the renovation takes place.

There have been a number of changes in the past 6 months amongst executive staff. Due to this a number of changes have been made and executive staff have been redeployed as well as given multi-tasking duties to ensure that management numbers are kept as lean as possible while services are kept at the highest levels. I want to take this opportunity to thank all the staff at the RSC for a job well done. More importantly I would like to record a big Thank You from all the staff at the Club to our members who contributed towards the staff bonus.

We are always looking into ways to improve communications to better keep members informed of happenings at the Club. To this extent more TV screens will be added in due course in both Club Houses apprising members of upcoming events and other information. Our website is also updated weekly and provides numerous levels of information.

Our beer prices for the past 6 months have been one of the most competitive in the country which is due to our negotiations with the breweries. Unfortunately the deal with Heineken ended in December 2016 and for Carlsberg 31st January 2017 will be the last day when beer is sold at RM7.50. We are continuing our negotiations with the breweries and hope to be able to convince them for less expensive rates to keep or beer prices as competitive as possible. At the time of writing we have negotiated with Carlsberg and will be selling Carlsberg Draught at RM6.80!. About the lowest price offered for a pint of beer. A number of liquor discounts were offered in the second half of 2016 and we will continue this trend



as we are constantly negotiating with our suppliers on reduced pricing in order to be able to pass on the lower rates to our members. Look out for our Whisky of the month sales.

On the F&B side the Chinese Restaurant has had rave reviews and I am happy to note that is well patronised on a daily basis. The Indian Stall at Kiara closed on December 19th and at the time of writing we have almost completed the procedures for sourcing and confirming a new operator to serve Indian cuisine at Kiara. Operators for the Japanese stall at Dataran are also being sourced and we hope to have this running by mid to end February.

2017 promises to be a great year both in terms of our social activities and sports. We remain committed to finding ways to better serve all of you and making the Club an indispensable part of our Members' lives.

Wising you the very best in the upcoming "Year of the Rooster"!

THE RSC GRANTED 60 YEARS LEASE EXTENSION

"THIS INSTITUTION SHOULD REMAIN FOREVER" HRH Sultan Salahuddin Abdul Aziz Shah

This article, the second of two, highlights the progression of the since Malaysia gained Club Independence on 31 August 1957 to where the Club is today under the 62nd President, Mr. Poovi Maniam. The earlier article, which appeared in the last issue of the Berita. provided insights into the Club's hallowed history over the period 1884-1957, as a British colonial Club, commencing with the tenure, the first President, John Pickersgill Rodger.

At dawn on 31th October 1957, the Malaysian flag took centre place over the Union Jack at the Club. Consistent with the high standards of a premier gentlemen's Club, the move forward was smooth and orderly. Some expatriate members, including civil servants planters, took advantage of the benefits of the Malayanisation program and returned to the United Kingdom and Australia. However, a sizeable number became absent members and maintained their ties with the Club.

By 1964, thanks to high rubber and tin prices, Kuala Lumpur was bustling with commercial activity. More Malaysians joined the Club and the Club membership grew to 4000 as compared to only 5 when it was founded.

In the same year there was an historical change of the baton to complete the transition. Tan Sri Taib Andak succeeded Mr. G. Preston as the first Malaysian President of the Club.



The Club also became more Asian in character with a larger number of members who were Malaysian professionals. A significant feature was the somewhat disproportionately large number of lawyers and judges who joined as members. Not surprisingly, the legal battles in the adjacent High Court often spilled over to the always packed Long Bar. The Club regulars included luminaries like Tan Sri Taib Bin Haji, Andak, Tan Sri Khir Johari, Kington Loo, Tan Sri Justice H.S.Ong, Tan Sri Hamzab B Abu Samah and Datuk Justice Harun Mhd Hashim who all subsequently served as Presidents.

The admission of senior staff from the newly formed diplomatic corps and the Malaysian Armed Forces swelled Membership numbers. Among them were Tan Sri Razali Ismail who subsequently became Malaysia's Permanent Representative to the United Nations, Tan Sri Thanabalasingim, who became the first Malaysian Chief of our Navy, Tun Haniff Omar, the former Inspector General of Police and General Zain Mahmud Hashim, the Chief of the Armed Forces.

RSC's Place in the Nation

Our first Prime Minister Tunku Abdul Rahman frequently visited the Club. Likewise, his successor Tun Abdul Razak who was also very close to the Club as reflected by the memorable quote by the current Prime Minster Dato'Seri Mohd. Najib Tun Abdul Razak in 2009.

Disaster hit the Club at around 10.30 p.m. on 20 December, 1970, when the main building was razed in a fire which started from its kitchen. The fire was doused by within an hour, but the damage caused by the fire amounted to M\$1.5 million; far more than the insured amount of M\$1 million. The President and the staff effectively handled the calamity although there was an ongoing children's Christmas party, all the guests and children were safely evacuated and there were no casualties. Surprisingly, 15 hours after the blaze, the Club's Annual Christmas party went on as usual. Since four

of the Club's Bars were destroyed, the Long Bar restricted to men only, was opened to women.

The Club was subjected to another disaster 18 days later. In January 1971, the Club was hit by floods and the Club's premises were submerged for three days. Several records were lost.

The then President, Tan Sri Khir Johari, was quick to submit proposals to Kuala Lumpur City Hall to rebuild with a new wing what was damaged by the fire. However, City Hall was keen on the construction of a civic centre over the site of the Club's field and a search commenced for a new site. Alternative sites were explored in Jalan Duta in Ampang and Damansara but none were found to be suitable. City Hall finally agreed, in July 1978, to the reconstruction of the Club's new building. Built in a similar Mock Tudor style, at a cost of M\$6.5 million, Members readily chipped in with financial contributions and it was ready for use in December 1980.

Our 100th Anniversary

The year 1984 marked the Club 100th year anniversary. More important, it was awarded the Royal status under the Patronage of the Sultan of Selangor, Sultan Salahuddin Abdul Aziz Shah who voiced his opinion that *"This institution should remain forever"*. From that day, the Selangor Club would be forever known as the Royal Selangor Club.

Another milestone was the opening of the Kiara Annexe Ground, by his Majesty Yang di- Pertuan Agong Tuanku Ja'faar Ibni Al- Marhum Tuanku Abdul Rahman, in 1998. This extension of the Club consists of a cricket and rugby pitch, which double up as a hockey and football field as well as tennis courts, a gymnasium and a swimming pool.



The PADANG

Widely acknowledged as the original Malaysian home of cricket, rugby, hockey and billiards, the RSC carried on its rich tradition as the bastion of Malaysian sport. Its prized jewel was the Padang which had been the focal point of sports in Malaysia for over 75 years. The first game of cricket played on this pitch was in the then Malaya in 1886.

Many cricketing legends have played at the Padang, including Sir Garfield Sobers, Dennis Lillee, the Chappell brothers, Basil D' Oliveira, Tom Graveney. In 1998, cricket moved to the Club's grounds at the Sports Annexe in Bukit Kiara which also hosted cricket greats like Aravinda De Siliva, Brian Lara, Sachin Tendulkar, Ricky Ponting and Muralitharan.

The Padang was also home to Malaysian rugby. In the 1980s, a group of enthusiasts successfully revived the Jonah Jones RSC Rugby Sevens. It currently attracts over 60 teams from around the world annually and the tournament has become one of the premier development tournaments in Malaysia and the region.

Over the years, many state and international sportsmen have come through the ranks of the Club. Among them, Dato Santokh Singh, Dato Dr Alex Delilkan who bowled the perfect first ball to beat the great batsman, Sir Garfield Sobers in 1964, Lall Singh, the only Test cricketer from Malaysia. Dr. Chan Onn Leng, the 'Flying Doctor', Dato Yogeswaran, and Past President Andrew Bryan Perera who played rugby for the country.



Equipped with various sporting facilities, including a gymnasium, a billiards room, and a darts area, the Club hosted a slew of international events for cricket, rugby, football, snooker, hockey and tennis and has done well in competitions. These include the Tri Nations Snooker Tournament, the RSC-Tiger International Soccer 7s. The Dato' Chu Ah Nge International Junior Football Tournament, Rugby's Jonah Jones 7s, the International Hockey 9s, the Hash Anniversary Run.

In keeping with the country's changing times and members' expectations, new sports sections were established over the past 3 decades. Among them was Golf in 1980, Darts in 1884, Musical & Arts in 1998, Motorsports in 1999, Dance Sport in 2000, Table Tennis in 2003, and Badminton in 2004.

Over the years the Club has nurtured several sports and developed numerous talented sportsman. This tradition has been steadfastly maintained and the Club now has junior development programs in tennis, swimming, football, hockey and badminton.

For decades the Club was also associated with its gastronomic delights. Members have a variety of food choices; Western, Chinese, Indian, Japanese and fusion food and the Club has become a preferred venue for wedding functions and social events. The combination of the ambiance and the affordable prices have contributed to the beverage outlets well patronized.

The history of the Club has to include the outstanding staff and individuals who dedicated their lives to serving the Club. Among them was Joe Spellman who served with distinction as the Manager / Secretary in the early 1950s and again in the late seventies. Life members will recall his high standards of etiquette and decorum and his insistence that Club male members donned a jacket and tie in the dining room after 7pm.

Another notable was Mr. Chew Heck Mitt, better known as "Ah Mit" who holds the record for having been the longest serving staff member. He joined the Club in 1908, became head boy in 1928 and in 1958 he was honoured with a gold watch for his half a century of service to the Club.

On the minus side, the Club has had its share of uncertainty. Besides the fire and the flood, it faced the possibility of relocation bankruptcy and even closure. The Club is now 133 years old. Although the façade shows no signs of ageing and remains as handsome as ever it masks several challenges. The membership is ageing. Heavy capital outlays are required for major electrical, plumbing and interior works. But the Club's traditional views on principles, sound management and care have enabled it to stay abreast through good times and bad.

Indeed, only last year, the new General Committee, headed by the current President Mr Poovi Maniam, was faced with the monumental challenge of addressing a carry forward budget deficit of RM1.4 million. Emphasizing on effective governance and financial discipline, the President and his team have commendably reversed the losses incurred by the Club, as reflected in the recent budget. The Club's financial situation is stable again as reflected by the current **Committee crediting RM 500.000** into a fixed deposit account for the first time after many years.

The spotted dogs are no longer around; the Padang is no longer with the Club; the external environment may have changed and like all great institutions the Club has to contend with a few prophets of doom—even the odd atypical, blinkered member who harbours the illusion that the Club is in a "crisis mode". The situation is otherwise. RESOLUTIONS PASSED AT THE EXTRAORDINARY GENERAL MEETING ON 18TH DECEMBER 2016

RESOLUTION 1

A motion proposing for the extension of the tenure of every President from one year (as per current Rule under Article 24.6 of the Constitutional Rules of the Club) to two years. Decision: Motion was carried.

RESOLUTION 2

Motion proposing to open invitations to companies on a profit sharing basis, for the service of operating, supplying and maintaining the slot machines.

Decision: A special committee to be formed to produce a comprehensive report which is to be presented to the members at a AGM for discussion and approval.

RESOLUTION 3

Dr. Ranjit Singh Mahli (Vice President) and Mr. Kalwant Singh (GC Member) to be removed from office on a vote of no-confidence. Decision: Motion was carried

RESOLUTION 4

Proposal to do away with the requirement to audit the sections by the External Auditors thus resulting in total cost savings amounting to some RM 21,400 per annum by the sections. It was proposed for the Club's Internal Auditors to audit the section accounts. Decision: Motion was carried.



For the year 2017 we are indeed pleased to present a Budget with a surplus of RM160 thousand.

From the graph you would note that from a deficit of RM1.4 million in 2015, we have forecasted a deficit of RM400 thousand for the year 2016.

We hope that this would be the beginning of a new trend and the club consistently recording a surplus henceforth. However, this calls for increased Sales at all our outlets, prudent cost control measures and efficient financial management.

BUDGET 2017 SOURCES OF INCOME



THE 2017 BUDGET

1. Subscriptions Income is the largest contributor at RM5.150 million which constitute 35% of the Total Source of Income for the Club. We have budgeted for 125 members to join the club during the year 20 17. In 2016 thus far, we have 92 members joining us.

A point to note here is that during the year, 635 members have become Life members and another 38 members have become life members without subscription. (673)

The net impact of this **change in status** is a reduction in income of RM475,440 per annum.

Therefore, it is incumbent upon us to go on a membership drive to keep the subscription at a healthy level.

Next, is the Net Profit from F&B Outlets at RM4.455 million which

constitute 31% of the Total Income Source.

You will note that the **average percentage of increase** for Sales in the various outlets in comparison to Forecast 20 16, average 3.5%; whereas for Cost of Sales, the average is 2.9%.

2. Other Revenue and Sundry Revenue make up 14% of the Income.

3. Slot Machine and Food Outlets Commission make up 5% each of the Total Income.

4. Incentive received from the Breweries by way of credit notes are being shown as an Income for the year 2017 and 2016 forecast.

The Budgeted credit notes or incentive is RM550 thousand for the year 2017, and RM404 thousand for 20 16 forecast. Incentives in 2015 amounted to RM167 thousand but were credited directly to Purchase cost of beers and to Sports Section Subsidy Account.

5. For the year 2017 this income and Fixed Deposit Interest constitute 4% each of the Total Income.

6. As for Fixed Deposit, we have budgeted to place an additional RM500 thousand in 2017.

7. Lastly Transfer Fee for new members is budgeted at RM226 thousand or 2% of the budget. This is based on 60 new members becoming members under this scheme.

For 2016 the new members under this scheme stands at 45.

As for Expenditure, Staff Salaries & Benefits constitute 52% of Total Expenditure.It is the largest expenditure.

It must be mentioned that outsourced House Keeping manpower and F&B outlet guest workers are now classified under administration expenses as provided for . The amount budgeted for 20 17 is RM721 thousand.

We have observed that in the past this expenditure has been charged to Salaries and Wages and in some years to Out Sourced HR Salary under Administration.

Next is Utilities which constitutes 19% of the Total Expenditure. followed by Administration, constituting 17% of the Total Expenditure.

Repairs and Maintenance constitute 8% of the total expenditure. Sport Sections budget under the club will henceforth capture the Financial Assistant provided by the Club and





COMPARING 2016 FORECAST WITH BUDGET 2017

a) Subscription Income for 2017 shows an increase of RM150,000. This is based on the club increasing its ordinary membership base by 125 members during the year.

During 2016, 92 new members joined the club.

Ordinary members who turned life members during the year and paying subscription is 635 and 38 members without subscription.

The total life members paying subscription stands at 2113 and those not paying stands at 266. (2379)

Privilege members paying subscription stands at 34 and not paying stands at 19 (53).

b) For 2017 we anticipate 60 members to transfer their membership to their family/friends.

For the year 2016, 45 new members joined through membership transfer scheme.

c) Rental from Function Rooms is budgeted at 15% increase over forecast.

d) As for Minimum Spending 20% increase is budgeted over forecast.

e) Incentive from Breweries is based on the new contract.

f) Commission from food Outlets. The main increase is from the Chinese restaurant. Based on current trends and actual realised for November and December 2016, it is anticipated the Chinese restaurant shall gross over RM1.2million in sales. At 20% commission the budgeted RM230 thousand is easily achievable. g) Slot machine NET takings have averaged RM60 thousand a month in 20 16. However, the last few months has exceeded RM65 thousand.

h) With regard, Gross F&B Profit, the budgeted increase over 2016 is 4.8%.

With regard Fixed Deposit, the additional 19 thousand is due to an additional 500 thousand being placed for the budget year.
