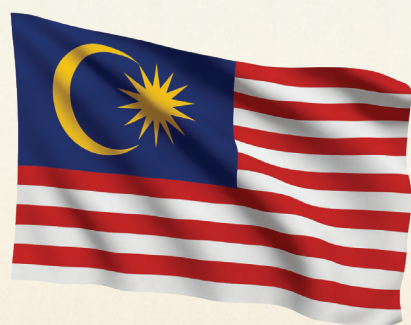

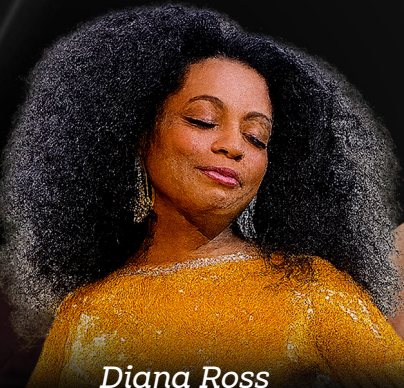

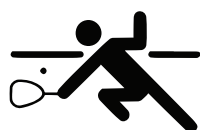

### International Day of Peace

*September 21*

We recently celebrated the 68th year of our Independence. As I highlighted in our August publication, Merdeka resonates differently with each of us. However, generally in my mind, it is about liberation from our past, with the promise of a better future.

On a personal note, my last Merdeka weekend was particularly eventful. I have two children born on the 31st of August and the 1st of September. Regardless of how old they have become, as parents, they will always be that little ones that we have nurtured with love in our hearts.

I would also like to extend heartfelt congratulations to the Organizing Committee for the Merdeka Day Celebration held in the Ballroom. It was a fantastic event! We have had a lively debate regarding the General Committee's proposal to address these concerns. Thanks to God's grace and the collective wisdom of our members, we have achieved the two-thirds majority needed to pass these Constitutional updates addressing the ROS "recommendations". We made these decisions together, and we will codify the changes in our Constitution. A huge thank you to GC Selva and the rest of his Subcommittee members who worked tirelessly on these resolutions. We genuinely appreciate the countless hours spent by the team.



## PRESIDENT SPEAKS

Now it is time to unite and collaborate on implementation and execution of all the resolutions approved during the EGM.

On the same topic regarding the resolutions proposed by the General Committee, we have received another visit from the Registrar of Societies on August 29th 2025. We informed the officials from ROS that we had just concluded our EGM, where we have addressed all concerns raised during their last audit, and we will be filing the updates to our Constitution with them in due course. As this article been written, I have been informed by the Club's Management that they are in the midst of finalizing the updates into the Constitution document and will share them with the General Committee for review and endorsement before we proceed to send it to the ROS for their acceptance and approval. We hope to complete this process as soon as possible and will keep members updated along the way.

Moving on to our Sports Sections, each section will be going through their AGM and office bearer elections in the next 1-2 months. As always, we strongly encourage all members to attend your respective section meetings. This is a great opportunity to learn about each section's activities over the past year, discuss any concerns, and share your valuable feedback and recommendations. Whether you're a new member or a long-time veteran, let's all participate in this annual tradition. For those able and willing, we encourage you to volunteer your time and energy to be nominated as an office bearer for the sections you are passionate about. And for those who are stepping down, on behalf of the Club, the General Committee, and all its members, I would like to extend our heartfelt gratitude for your contributions to the Section and to the Club. Your contribution will always be remembered.

I always believe that anyone and everyone who joins this club desires to be a member for as long as possible. If this premise holds true, then with God's blessing, all of us could potentially become Life Members in the future. Historically, Life Members are about 45% to 48% of our membership based on the membership records the last few years, making this group as one of the largest within the club. Their contributions to our club's development over the years should never be overlooked. They were there before, and they are still here today, and they will continue to contribute to the evolution of the Club.

At our AGM in 2018, a resolution was presented by our Past President Mr. Karu Selvaratnam to establish the Life Member Fellowship Group (LMFG) which was subsequently approved by the floor, following prior approval from the General Committee on December 8, 2017. Recently, the General Committee has received a proposal from our Past President Ronnie Q, to formalize this arrangement and advance it to the next phase. It is heartening to see many of our veteran members still actively participating in club activities. In fact, some of the most active members of the Club are Life Members. The Club is collaborating with the LMFG's Pro Tem committee to refine its governance and include the same into the Club's Bye Law as required by the Resolution approved in 2018. # Compliance and change EGM amendments to the RSC constitution

24 August 2025

## ROS NOTICE OF AUDIT AND COMPLIANCE

- PRESIDENT SPEECH AND Note on Financial Performance
- ROS : Date of Audit: **29.04.2025**
- **PRESIDENT OUTLINED KEY ROS REQUIREMENTS TO GC ON 29.04.2025 (GC MOM Page 1/17)**

1. Amend the Structure & Composition Of GC : Club's total number of Office-Bearers (the number of GCs) is inconsistent with Constitution (10 vs 11).
2. Club's Secretary shall be a GC Member with specific Roles & Responsibilities. The GM shall report to the Secretary
3. Club's shall have a Treasurer (replacing the Finance Chairman) with specific Duties. The Finance Manager shall report to the Treasurer.
4. Define Duties of Principal Officer Bearers (who are responsible to ROS)
5. All Elected GC members shall be office-Bearers.
6. Club Financial Year / Late Filing of Management Accounts.
7. Financial Management Anomalies.
8. Tender, Contracts - Financial Limits Anomalies.

## KEY HIGHLIGHTS OF MITIGATING ACTIONS

- **President presented ROS recommendations at Town hall on 31.05.2025**
  - **Officially announced the setting up of a Governance & Compliance Team**
  - **Current Scenario:**
1. President wrote an Article in RSC Berita on the above.
  2. Till Today – Only 2 Members have brought 2 concerns to GC to correct some errors on the proposed Amendments.
  3. I personally thank these Members who have been **Pro-Active to resolve issues after circulation of the EGM notice some 54 days ago.**
  4. The 1st Notice of Resolutions was issued on July 1st (almost 2 months ago).
  5. The 2nd Notice of Resolutions was issued on July 23rd.
  6. The GC has been very proactive in its transparency and disclosure.
  7. **The GC has been placed under huge pressure to comply within 90 days or so.**
  8. Did the GC have time or space to take its sweet time and suffer to bureaucracy ?
  9. We hope Members understand the High Risks involved and volunteer work undertaken by Governance & Compliance Team and the GC.
  10. The GC shall not take the risk for failing to take urgent actions.
  11. **It is already 4 months Since April 2025**



## THE CLUB'S TOP PRIORITY ACTION PLANS / RESPONSE

1. President: Formation of Governance and Compliance (GOC) Committee on 29.4.2025 to act as the Constitutional Review Committee with the immediate effect and tasked with sole purpose of reviewing the Constitutional Amendments.
2. The GOC Committee team worked over 2 months (8 weeks/60 days) almost continuously to review all the relevant Articles which required Amendments.
3. The GOC committee comprised of the President, Vice-President, Constitutional Review Lead by Selvaraja (Legal/Governance Lead), Mr. Muniandy (Corporate Finance & Compliance Advisor), Mr. Dhanendran (Corporate Advisor) and IAC Mr. Ramasamy.
4. The GOC Committee set out Basic Principles for the proposed Amendments:
  1. ROS Requirements and Society Act 1966 legal framework
  2. BASED ON BEST PRACTICE COMPARISONS amongst CLUBS CONSTITUTION
  3. Market Best Practices referred are : PSC, RLC, KGNS AND OTHERS
  4. Sports Sections Governance Model: RSC
5. Schedule of Meetings by GOC and GC as attached.
6. All these continuous hard-work shows the critical importance given for the compliance to ROS recommendations, top priority attached to such matters and the GC's tenacity to work under pressure.

4. Lack of Supervision and Monitoring of Performances

## Financial Initiatives and Challenges

- **Club GL and Accounts** : Undertaking proper separation between Club Accounts and Sports Accounts: Hotch-potch?

### • Bank Reconciliations: Serious gap

- The Club has unreconciled Bank Accounts. A substantial discrepancy between the Bank Statements and the Club's accounting system.
- *Cash At Hand, Contra – Account, Accounts Payables, Other Payables\**

### • Procurement Challenges (140yrs) :

- Managing PO - ?
- Lack of Contracting and procurement procedures.
- Beverage Procedures (Status of Purchases, Trade Off, Cash incentives, Pricing mechanism, Quarterly reviews!)
- Financial Regulations (freebies, waivers, rentals, discounts)

## SERIOUS ANOMOLIES IN CURRENT CONSTITUTION: Few examples : Recommendations by Tender Committee

1. SERIOUS ANAMOLY IN FINANCIAL LIMITS FOR PROCUREMENT:
  - Art 6.14.1: For purchases in excess of RM2,500 but not exceeding **RM 5,000**.
  - Art 6.14.2 - For purchases in excess of **RM10,000** but not exceeding RM50,000
  - **Serious Financial Anomaly** pointed by Tender Board to GC!
  - Who has authority to issues RFQ/Tenders for Purchases between RM 5,000 to RM10,000??
  - Breakdown in **Financial Governance**, Exposure to Risk and Audit Recommendations.

2. Tenders not raised by Club on Timely manner : 6.15.1.11 (TBC)

3. Art: 31.2 Complaints or suggestions may be submitted by members by **letter** to the Secretary.

- Series of issues. Need timely actions and responses.
- Members can sent by email / WhatsApp, Management must act with GC guidance!

4. Purchase Order (V. Poor Management) : **over 4,000 POs** for 2024!

## RESOLUTION 1 – KEY AMENDMENTS

### COMPOSITION AND STRUCTURE OF GC

- The Secretary & Treasurer shall be office-Bearers in the GC.
- Thus, the Total number of GCs is increased from 10 to 12.
- Secretary shall be an official Member of the General Committee with Roles and Responsibilities – Art 26.21.3.
  - *ROS proposes that the GM shall report to the Secretary.*


### **The Little Joys That Shape the Greater Peace**

# Advance Care Planning (ACP): Dying with Dignity, Living with Clarity

Every month, we read the solemn page in the *Berita* that reminds us of fellow members who have left us. Many of them were prominent, distinguished personalities who contributed much to the Club and to society. For some, their absence was long felt before the official announcement of their passing often because illness, frailty, or an accident kept them away from Club events.

The truth is, as much as we continue with our lives, many of us are also facing the realities of ageing, illness, and overall decline. Some of our senior members would love nothing more than to step into the Club again, but failing health prevents them. It is in this context that we need to talk honestly and courageously about Advance Care Planning (ACP).

### What is ACP?

According to the Ministry of Health, Advance Care Planning is a process in which a person communicates their values and preferences for future medical care to family members and healthcare providers. These wishes are then documented so that when a person can no longer speak for themselves, their loved ones and doctors know what to do.

It's about taking control now so that when your time comes, your dignity, comfort, and quality of life remain at the centre of care.

### Why It Matters

Imagine this: a member has been living with advanced heart failure, or perhaps a long battle with cancer. The illness has taken its toll. One day, his heart stops. The doctors could try to resuscitate him, put him on machines, insert tubes, and prolong his life but at what cost? Often, the quality of life is reduced to zero, with immense suffering for both the patient and the caregivers.

ACP gives you the power to say:

- "No, I do not want to be resuscitated if my condition is beyond recovery."
- "Yes, I want to die peacefully, without tubes or machines keeping me alive unnecessarily."
- "I do not want to be a burden to my family, financially or emotionally."

In short, ACP is about choosing dignity over unnecessary suffering.

### It's Not Just for the Elderly

While ACP is crucial for our senior members, it is equally important for the not-so-old. Misfortunes don't give a warning; they just happen. We might

be in the prime of our lives, only to be struck by a sudden accident that leaves us paralyzed or in a coma. We must do away with the "It will not happen to me" attitude and be prepared for unforeseen situations. By the time an emergency occurs, it could be too late to make your wishes known.

### The Tools: Advance Directives & DNR Orders

An Advance Medical Directive (AMD), often called a living will, is a written statement where you record your wishes for future treatment. You may also appoint someone you trust to speak on your behalf when you cannot.

Key components include:

- **Living Will** – Specifies the treatments you want or do not want (e.g., ventilator, feeding tubes).
- **Health Care Proxy** – Naming a person to make decisions for you.
- **Do Not Resuscitate (DNR) Order** – Directing doctors not to perform CPR if your heart stops.

### Breaking the Taboo

In Asian culture, talking about death is often considered taboo. But times are changing. Studies show that many Malaysians actually support ACP. By talking to your loved ones now, you spare them the emotional agony of guessing what you would have wanted in a crisis. You also give them the strength to stand up to well-meaning but misguided pressure from others. For instance, if a close relative insists on seeing "this doctor or that doctor," even when the situation is hopeless, your family can simply and politely say that they are just following your instructions as outlined in your AMD.

### A Final Word to Members

To my fellow Club members, ACP is about being strong enough to face life's reality and wise enough to plan for it.

When the time comes or something serious happens, do you want to leave this world as a living skeleton hooked up to tubes or a vegetative state—or as the dignified person your family, friends, and Club members remember with deep respect and love?

Give the word to your loved ones now. Put it in writing if you can. Let them know: "When my quality of life is gone, do not prolong my suffering. Let me go peacefully." In doing so, you will not only protect your dignity, but also lift a heavy burden off those you love most.

# The Kinabalu Club – Heritage, fellowship and legacy since 1903

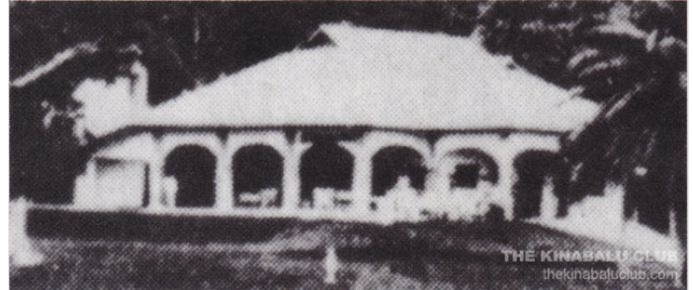

The logo represents a group of people gathered together in fellowship. The human figure is based on a local motif of man. The Kinabalu Club was formed in 1903, making it the oldest club in Kota Kinabalu.

True to the old adage that a club to an Englishman is his second house, within four years after the founding of Jesselton in the British North Borneo the Governor constituted the Sports Club in Jesselton as a vehicle for introduction and promotion of both indoor and outdoor sports and game; and as a venue for social activities. The club as an institution grew with the town over the years, adapted to social, economic, and political changes, managed to resist the destructive passages of time and merged as the second oldest club in Sabah after the Sandakan Recreation Club. The founding of the club can be traced to the founding of Jesselton.

# Ayam Masak Bawang

## INGREDIENTS A

10 nos bigonions (sliced thinly) - fry till brown and keep aside.  
 1 nos chicken (cut into big pieces)  
 1 tbsp turmeric powder )  
 1 tsp salt ) – marinade. Marinate chicken and set aside for 1 hour.

## INGREDIENTS B (FOR TEMPERING)

2-inch cinnamon  
 6 nos cloves  
 6 nos cardamoms  
 2 pcs pandan leaves  
 2 stalks serai  
 6 nos shallots (sliced)

## INGREDIENTS C

3-inch ginger }  
 8 pips garlic } – blend finely  
 3 big onions }

## INGREDIENTS D (SPICE POWDERS)

2 tsp jintan manis powder  
 2 tsp jintan putih powder  
 1 tsp garam masala powder  
 2 tbsp coriander powder  
 1 tsp turmeric powder

## INDREDIENTS E (SAUCES)

3 tbsp chilli sauce  
 3 tbsp tomato sauce  
 2 tbsp oyster sauce  
 2 tbsp thick soy sauce  
 1 tbsp cukup rasa

## METHOD

1. Fry the marinated chicken in a wok till 80 % done. Drain and set aside.
2. Remove oil leaving behind 3/4 cup. In that oil fry Ingredients B till aromatic & the shallots are brown.
3. Add in Ingredients C & continue frying for 5 mins.
4. Add in Ingredients D, mix well and continue to fry till oil emerges on top.
5. Add Ingredients E, stir well and cook for 5 mins. Add in the fried chicken pieces and stir well.
6. Lastly add in the fried onions and cook for a further 5 mins.
7. Garnish with green chillies and coriander leaves.

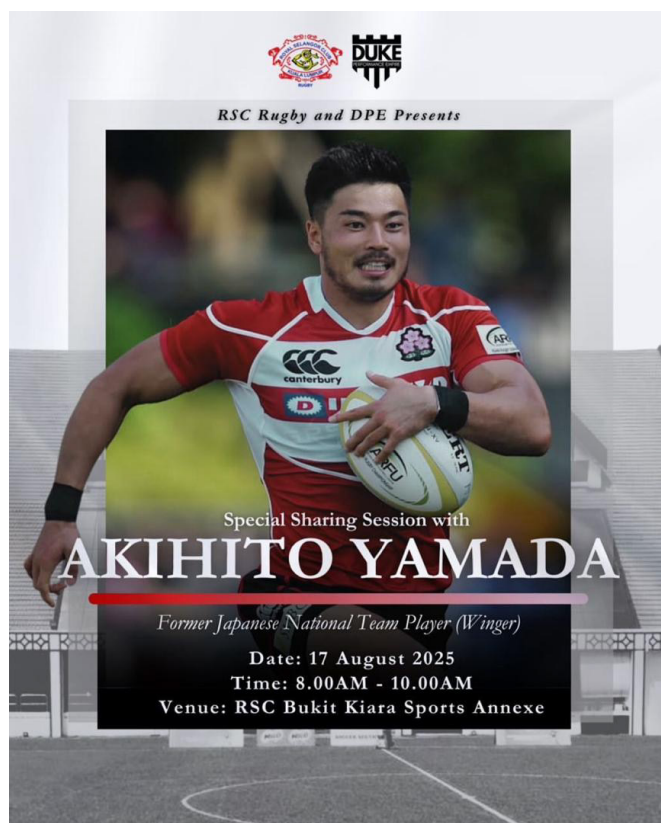

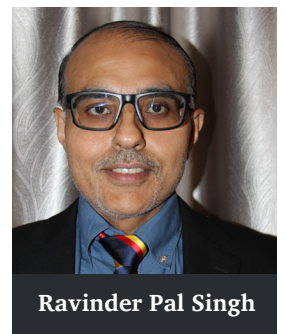

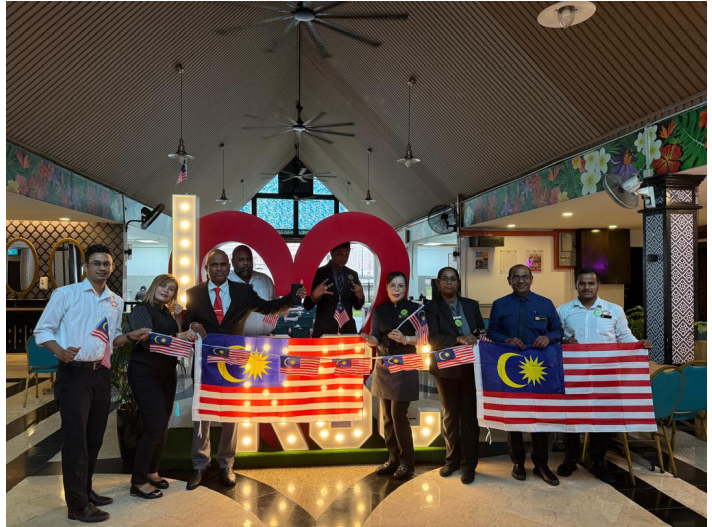
We encourage all members and staff to take note of these AED locations, as every second counts during a medical emergency. With your awareness and quick action, lives can be saved.

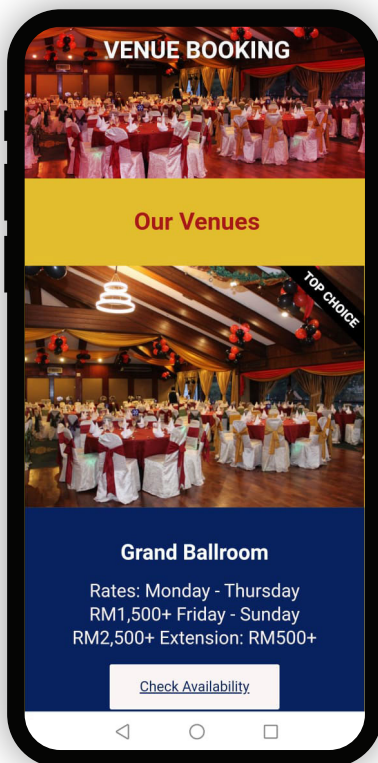

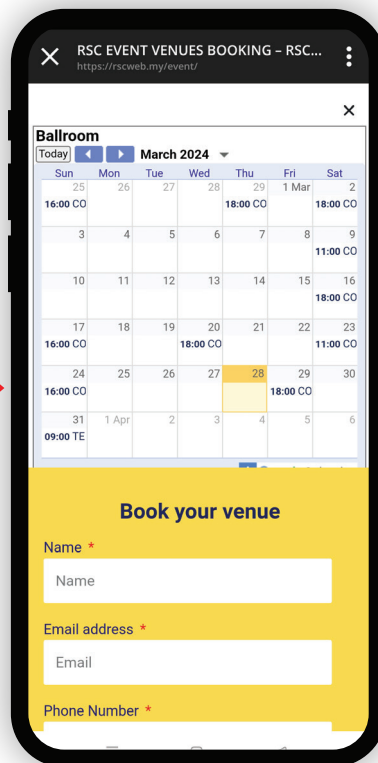

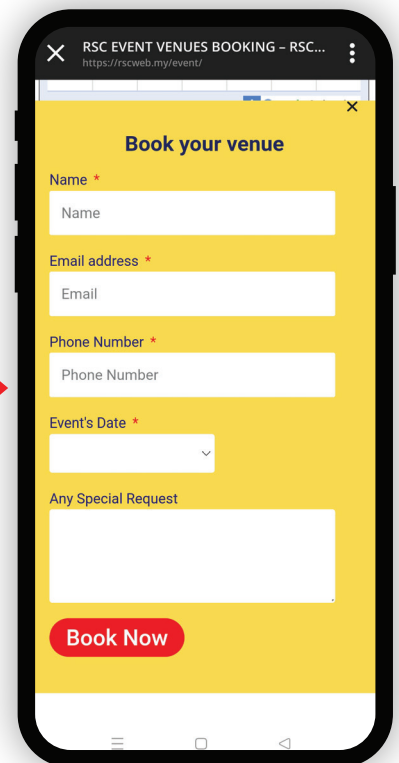
